

WELCOME PACKAGE by GSSA.

GSSA Requirements for all the Events.

Note: Smoking, Tobacco, Alcohol, any Intoxicants or Drugs are not allowed at GSSA Property at any time.

A. All PROGRAMS or EVENTS must be booked in person, after signing the booking contract with GSSA. No Phone call bookings are accepted. Temporary reservation can be made for up to maximum of 2 weeks.

B. Family or Person who want to book any event at the GSSA will be responsible for all the bhetas. Non-refundable deposit as stipulated will be required at the time of the booking and full bheta is required one week prior to the event date. Booking is confirmed once the GSSA treasurer issues a payment receipt.

1. All Programs at GSSA will be performed according to the GUR-MARYADA and rules of the Guru-Ghar.
2. Tables and Chairs in the Langar Hall are for injured/disabled/elderly handy-capped only as per HUKAMNAMA from Shri Akal Takht sahib.
3. While inside the building everyone must keep his or her head covered all the time.
4. No shoes are allowed inside the building except in the entrance lobby and bathrooms. Shoes must be removed and put in the shoe racks. No shoes are allowed in the Langar hall and kitchen.
5. Giani Ji and Ragi Jatha of the Guru-Ghar will perform wedding and all other Programs at GSSA. In the event, outside Ragi Jatha performs the Anand Karaj, the Gurdwara Ragi Jatha will recite the opening Shabad. The Behta to outside Ragi Jatha will be paid by the family making such arrangement. Behta for the GSSA Ragi Jatha is included in the booking fee.
6. For outside TENT, it will be the responsibility of the Family to get PERMIT from the Bridgewater Township and provide a copy of receipt to the Working Committee and tent installer before putting the tent.
7. For Wedding Ghori, Family is required to get an accidental Insurance with The Garden State Sikh Association, Inc. as ADDITIONAL INSURED ON THE POLICY and a copy of insurance certificate must be provided to the Working Committee, a week before the Wedding and/or sign an Indemnification certificate.

8. Dance, Songs, Bolian, Dhol and any other Music is not allowed within 100 feet of the Guru-Ghar building.
9. Family member should accompany the event ORGANISERS inside GSSA Building and must notify the Event Organizers, Caterers, Tent installers and all other vendors about the rules and regulations.
10. During the ANAND-KARJ Ceremony Bride-Groom is not allowed to wear Sehra, Kalgi and Haar etc.
11. Anand Karj Rasam will be performed according to GUR-MARYADA only. Throwing of flower petals and spraying of any kind of perfume is not allowed.
12. All 'SAGUN RASAMS' and PHOTOS for SAGUN etc. must be done outside the DARBAR Hall.
13. GSSA will issue the marriage certificate only if ANAND-KARJ was performed at GSSA premises by designated staff.
14. GSSA will perform Anand Karaj services at the premises of Gurudwara Sahib only.
15. Family and Guests will be required to follow all the rules and regulations of GSSA while at GSSA. Family or any other person will not be allowed to move/relocate anything in the GSSA building without the permission of the Working Committee's approval. Sprinkler/Alarm/Mechanical/Elevator Service rooms cannot be used for anything including storage.
